**NOW THEREFORE, BE IT RESOLVED** by the Rochester City Council that the additions and adjustments to the Master Fee Schedule, as attached to this Resolution, are hereby approved.



**BE IT FURTHER RESOLVED** that all previously identified fees and charges for the enumerated items in the attachment are no longer in effect once this Resolution is adopted and takes effect.
